

No. DS. 47/2011/Pt/23 dtd 20/09/11 allotting 630.00 Qtls of Special Adhoc Additional BPL Rice for each month of Oct/Nov/Dec'11 for Tinsukia Sub Division, the sub allocation is hereby made for 629.90 Qtls of Spl. Adhoc Addl. 
